Legislative Report

The 2020 State Legislative Session began on February 5th and ended on May 6th.

Because of the ongoing Coronavirus Pandemic, the Capital Complex closed on March 13 and remained closed until a the legislative leadership convened a brief session on May 6 with most members absent to formally close the regular session. Only one piece of legislation was passed in this session. On March 11, a bonding bill was passed and signed by Governor Lamont.

Prior to the closure, there had been no legislation introduced in the 2020 Legislative Session that adversely impacted the antique auto hobby. So that is a good thing!

The path forward continues to be unclear. Hughes and Cronin provided us with an update of what they anticipate will take place. The Democratic leadership has indicated to the various Committee Chairpersons that it will consider one bill that includes its "priorities." That one bill will likely contain a variety of unrelated topics in it. The expectation is that the Legislature will be called into a no more than one day Special Session in the early to late June time period.

Legislative History - \$500 Assessment

A few years back, I went to the library in the legislative office building and researched the history of the \$500 assessment statute to try to understand the timeline of when the \$500 assessment first went into effect, and the vehicles it applied to through the years. Provided below are those statutes and a brief summary of each. While it may be painful to read, the details do provide some historic insights as to how we got to where we are.

Briefly, the \$500 assessment was first enacted in 1973, and applied to those vehicles issued antique plates in accordance with Section 14-20. The definitions of antique, rare and special interest motor vehicles and modified antique motor vehicles were added in 1979. In this 1979 change, Section 14-20 listed only antique, rare or special interest motor vehicles. It did not list modified antique motor vehicles. As such, according to the statutes, the \$500 assessment never literally applied to modified antique motor vehicles in the historic statutes. However, as we all know as a practical matter, DMV issued modified antique motor vehicles antique plates in accordance with Section 14-20, and the \$500 assessment therefore applied. That is until 2008, when Public Act 08-150 extended the maximum \$500 assessment to any antique, rare or special interest motor vehicle (not just those issued number plates in accordance with Section 14-20.) This was corrected by our efforts in 2009, by Public Act 09-187, which represents the current statute. Here are the details:

<u>Public Act 73-531: An Act Concerning the Taxation of Antique Automobiles</u>

Section 12-71 of the general statutes is repealed and the following is substituted in lieu thereof:

"... All property subject to this section shall be valued at the same percentage of its then actual valuation as the assessors have determined with respect to the listing of real estate for the same year, except that vessels shall be valued in accordance with the provisions of section 12-71a, and ANY MOTOR VEHICLE FOR WHICH NUMBER PLATES HAVE BEEN ISSUED UNDER SECTION 14-20 SHALL BE ASSESSED AT A VALUE OF NOT MORE THAN FIVE HUNDRED DOLLARS except when otherwise provided by law." - Text in all capitol letters was added by this act. -

At the time Public Act 73-531 was passed into law, Section 14-20 of the General Statutes read:

The commissioner may issue special number plates for automobiles manufactured at least twenty-five years prior to the date such number plates are issued, such special number plates to be issued on a permanent basis and to conform, as nearly as may be, to the number plates used in this state at the time of the manufacture of such automobile. Issuance of such special plates shall be restricted to motor vehicles which are restored and maintained for use in exhibitions, club activities, parades and other functions of public interest but not for general transportation. The commissioner shall charge a fee for such plates which shall cover the entire cost of making the same. Such plates shall be issued in addition to the number plates required by the provisions of this part.

<u>Summary of Public Act 73-531</u>: This 1973 Act is the very first time the maximum \$500 assessment applied to antique vehicles. It is noted that the assessment applies to any automobile 25 years old or older.

<u>Public Act 79-25 An Act Concerning Historical, Special or Rare Vehicles</u>

Section 14-1 of the general statutes is amended by adding subsections (63) and (64) as follows:

(NEW) (63) "Antique, rare or special interest motor vehicle" means any motor vehicle twenty-five or more years old which has not been altered or modified from the original manufacturers specifications and which, because of its historic interest, has been preserved.

(NEW) (64) "Modified antique motor vehicle" means any motor vehicle twenty-five years of age or older which has been modified for safe road use, including but not limited to, modifications to the drive train, suspension, braking system and safety or comfort apparatus.

Section 14-20 of the general statutes is repealed and the following is substituted in lieu thereof:

The commissioner may issue special number plates for [automobiles manufactured at least twenty-five years prior to the date such number plates are issued] ANTIQUE, RARE, OR SPECIAL INTEREST MOTOR VEHICLES, AS DEFINED IN SUBSECTION (63) OF SECTION 14-1, AS AMENDED BY SECTION 1 OF THIS ACT, such special number plates to be issued on a permanent basis and to conform, as nearly as may be, to the number plates used in this state at the time of the manufacture of such [automobile] MOTOR VEHICLE. [Issuance of such special plates shall be restricted to motor vehicles which are restored and maintained for use in exhibitions, club activities, parades and other functions of public interest but not for general transportation.] The commissioner shall charge a fee for such plates which shall cover the entire cost of making the same. Such plates shall be issued in addition to the number plates required by the provisions of this part. - Text in brackets [*] was deleted by this act. Text in all capitol letters was added by* this act. -

Subsection (b) of section 14-16a of the general statutes is repealed and the following is substituted in lieu thereof:

(b) (1) All motor vehicles ten or more years old which are registered in this state and which were originally used or designed as fire apparatus and which are of historical or special interest as determined by the commissioner of motor vehicles, (2) ALL ANTIQUE, RARE OR SPECIAL INTEREST MOTOR VEHICLES AND (3) ALL MODIFIED ANTIQUE MOTOR VEHICLES shall, upon transfer of ownership, be presented for inspection at any of the state motor vehicle department offices to determine whether such vehicle is in good mechanical condition

before registration can be issued to the new owner of such vehicle. The determination as to the mechanical condition of such vehicles DESCRIBED IN SUBDIVISIONS (1) AND (2) OF THIS SUBSECTION shall be made only upon inspection of the original equipment and parts of such vehicles or any functional reproductions thereof. THE DETERMINATION AS TO THE MECHANICAL CONDITION OF MODIFIED ANTIQUE MOTOR VEHICLES SHALL BE DETERMINED BY INSPECTION OF THE ORIGINAL EQUIPMENT AND ANY FUNCTIONING REPLACEMENTS THEREOF. There shall be a fee of two dollars for such inspection. The commissioner may adopt such regulations as he deems necessary to implement the purposes of this subsection. - Text in all capital letters was added by this act.-

Summary of Public Act 79-25: In 1979, this act added the definitions of antique, rare and special interest motor vehicles, and modified antique motor vehicles to the statutes for the very first time. This act also changed Section 14-20 on special plates, indicating that the applied to only the newly defined "antique," rare or special interest motor vehicle" and not "modified antique motor vehicles." As we know, DMV's standard practice is to issue antique plates to any antique motor vehicle including those that are modified, even though these statutes did not call for them to do so at that time. The fact that modified antique motor vehicles were not specifically cited in this section of this public act in 1979 would appear to be the underlying cause for the that bit us in the behind with Public 08-150 some 30 years later. Public Act 08-150 potentially inadvertently excluded modified antique motor vehicles from the maximum \$500 assessment. This is the issue we corrected in the 2009 legislative session with Public Act 09-187. This 1979 public act also revised the inspection statute (Section 14-16a Subsection (b)) by limiting the safety equipment required on an antique, rare or special interest motor vehicle to that original supplied with the vehicle. This is the very first use the new modified antique motor vehicle definition in the state statutes. The only other use of this definition that I am aware of is Section 14-62b, where dismantlement and sale or purchase of parts for antique motor vehicles are excluded from the requirement to obtain a motor vehicle recycler's license.

<u>Public Act 80-42 An Act Concerning Number Plates for</u> Antique, Rare or Special Interest Motor Vehicles.

Section 14-20 of the general statutes is repealed and the following is substituted in lieu thereof:

The commissioner may issue special number plates for antique, rare, or special interest motor vehicles, as defined in [subsection] SUBDIVISION (63) of section 14-1, as amended by section 1 of [this act] PUBLIC ACT 79-25 such special number plates to be issued on a permanent basis [and to conform, as nearly as may be, to the number plates used in this state at the time of the manufacture of such motor vehicle]. The commissioner shall charge a fee for such plates which shall cover the entire cost of making the same. Such plates shall be issued in addition to the number plates required by the provisions of this part.- *Text in brackets* [] was deleted by this act. Text in all capitol letters was added by this act. —

<u>Summary of Public Act 80-42</u>: This 1980 act eliminated the requirement that antique plate resemble those plates issued the year the vehicle was manufactured as closely as practical.

Public Act 83-515 An Act Concerning Number Plates for Antique, Rare or Special Interest Motor Vehicles. Section 14.20 of the general statutes is repealed and the

Section 14-20 of the general statutes is repealed and the following is substituted in lieu thereof:

The commissioner may issue special number plates for antique, rare, or special interest motor vehicles, as defined in subdivision (63) of section 14-1, such special number plates to be issued on a permanent basis. The commissioner shall charge a fee for such plates which shall cover the entire cost of making the same. [Such plates shall be issued in addition to the number plates required by the provisions of this part.] AN OWNER OF AN ANTIQUE, RARE OR SPECIAL INTEREST MOTOR VEHICLE MAY USE HIS OWN PORCELAIN NUMBER PLATE IN PLACE OF THE PLATES ISSUED BY THE COMMISSIONER PROVIDED (1) SUCH PLATE WAS

ORIGINALLY ISSUED BY THE DEPARTMENT AND (2) SUCH OWNER FILES WITH THE COMMISSIONER A DESCRIPTION AND THE NUMBER OF SUCH PLATE AND ANY ADDITIONAL INFORMATION THE COMMISSIONER MAY REQUIRE. - Text in brackets [] was deleted by this act. Text in all capitol letters was added by this act. -

<u>Summary of Public Act 83-515</u>: This 1983 act eliminated the requirement to issue a set of regular plates along with the special antique plates. I am not sure if the actual DMV practice was to issue two sets of plates for antique cars prior to 1983.

Public Act 84-429 An Act Implementing the Law Revision Commission's Technical Revision of the Motor Vehicle Laws.

Sec. 52. Section 14-20 of the general statutes is repealed and the following is substituted in lieu thereof:

The commissioner may issue special number plates for antique, rare, or special interest motor vehicles, [as defined in subdivision (63) of section 14-1,] such special number plates to be issued on a permanent basis. The commissioner shall charge a fee for such plates which shall cover the entire cost of making the same. An owner of an antique, rare, or special interest motor vehicle may use his own porcelain number plate in place of the plates issued by the commissioner provided (1) such plate was originally issued by the department and (2) such owner files with the commissioner a description and the number of such plate and any additional information the commissioner may require. - *Text in brackets* [] was deleted by this act.

<u>Summary of Public Act 84-429</u>: This 1984 is a minor non-intent change.

Public Act 00-169 An Act Revising Certain Motor Vehicle Laws.

Sec. 21. Section 14-20 of the general statutes is repealed and the following is substituted in lieu thereof:

- (a) The commissioner may issue special number plates for antique, rare or special interest motor vehicles, such special number plates to be issued on a permanent basis. The commissioner shall charge a fee for such plates which shall cover the entire cost of making the same. An owner of an antique, rare or special interest motor vehicle may use [his] such owner's own porcelain number plate in place of the plates issued by the commissioner provided (1) such plate was originally issued by the department, and (2) such owner files with the commissioner a description and the number of such plate and any additional information the commissioner may require.
- (b) Notwithstanding the provisions of subsection (a) of this section, section 14-18, as amended, and section 14-21b, as amended, the owner of an antique, rare or special interest motor vehicle may be authorized by the commissioner to display a number plate originally issued by the Commissioner of Motor Vehicles corresponding to the year of manufacture of such antique, rare or special interest motor vehicle. The commissioner shall issue a certificate of registration, as provided in section 14-12, as amended by this act. Such registration shall be valid, subject to renewal, so long as the commissioner permits. Thereafter, the registration number and number plates, if any, which were assigned to such motor vehicle before such registration and number plates were issued under this section, shall be in effect. Each such number plate authorized for use by the commissioner shall be displayed in a conspicuous place at the rear of such motor vehicle at all times while the vehicle is in use

or operation upon any public highway. A sticker shall be affixed to each such number plate to denote the expiration date of the registration, unless the commissioner authorizes the sticker, or other evidence of the period of the registration, to be placed elsewhere or carried in such motor vehicle. The commissioner may adopt regulations, in accordance with chapter 54, to implement the provisions of this subsection. Text in brackets [] was deleted by this act. Underlined text was added by this act.

<u>Summary of Public Act 00-169</u> This was the 4C's sponsored year of manufacture plate change allow these plates to be displayed on antique rare or special interest motor vehicles.

Public Act 01-191 AN ACT CONCERNING REGISTRATION STICKERS ON MOTOR VEHICLES AND CONCERNING SPECIAL NUMBER PLATES AND IDENTIFICATION CARDS FOR DISABLED VETERANS WHO HAVE TRAUMATIC BRAIN INJURY.

Sec. 2. Subsection (b) of section 14-20 of the general statutes is repealed and the following is substituted in lieu thereof:

(b) Notwithstanding the provisions of subsection (a) of this section, section 14-18 and section 14-21b, the owner of an antique, rare or special interest motor vehicle may be authorized by the commissioner to display a number plate originally issued by the Commissioner of Motor Vehicles corresponding to the year of manufacture of such antique, rare or special interest motor vehicle. The commissioner shall issue a certificate of registration, as provided in section 14-12. Such registration shall be valid, subject to renewal, so long as the commissioner permits. Thereafter, the registration number and number plates, if any, which were assigned to such motor vehicle before such registration and number plates were issued under this section, shall be in effect. Each such number plate authorized for use by the commissioner shall be displayed in a conspicuous place at the rear of such motor vehicle at all times while the vehicle is in use or operation upon any public highway. A sticker shall be affixed to each such number plate to denote the expiration date of the registration, unless the commissioner authorizes the sticker, or other evidence of the period of the registration, to be placed elsewhere or carried in such motor vehicle. Such sticker may contain the corresponding letters and numbers of the registration and number plate. The commissioner may adopt regulations, in

accordance with chapter 54, to implement the provisions of this subsection. *Text in brackets* [] was deleted by this act. Underlined text was added by this act.

<u>Summary of Public Act 01-191:</u> Change allowing DMV to include plate number on sticker.

Public Act 02-70 AN ACT REVISING CERTAIN MOTOR VEHICLE LAWS

Sec. 50. Subsection (b) of section 14-20 of the general statutes, as amended by section 2 of public act 01-191, is repealed and the following is substituted in lieu thereof (*Effective July 1, 2002*):

(b) Notwithstanding the provisions of subsection (a) of this section, section 14-18 and section 14-21b, the owner of an antique, rare or special interest motor vehicle may be authorized by the commissioner to display a number plate originally issued by the Commissioner of Motor Vehicles corresponding to the year of manufacture of such antique, rare or special interest motor vehicle. The commissioner shall issue a certificate of registration, as provided in section 14-12, as amended by this act. Such registration shall be valid, subject to renewal, [so] as long as the commissioner permits. Thereafter, the registration number and number plates, if any, which were assigned to such motor vehicle before such registration and number plates were issued under this section, shall be in effect. Each such number plate authorized for use by the commissioner shall be displayed in a conspicuous place at the rear of such motor vehicle at all times while the vehicle is in use or operation upon any public highway. A sticker shall be affixed to each such number plate to denote the expiration date of the registration, unless the commissioner authorizes the sticker, or other evidence of the period of the registration, to be placed elsewhere or carried in such motor vehicle. Such sticker may contain the corresponding letters and numbers of the registration and number plate. The commissioner may adopt regulations, in accordance with chapter 54, to implement the provisions of this subsection. Text in brackets [] was deleted by this act. Underlined text was added by this act.

<u>Summary of Public Act 02-70</u> Editorial change to the statute.

Public Act 05-218 AN ACT AMENDING CERTAIN MOTOR VEHICLE STATUTES

Sec. 42. Subdivision (3) of subsection (a) of section 14-1 of the general statutes is repealed and the following is substituted in lieu thereof (*Effective July 1, 2005*):

(3) "Antique, rare or special interest motor vehicle" means a motor vehicle [twenty-five] twenty years old or older which is being preserved because of historic interest and which is not altered or modified from the original manufacturer's specifications.

Sec. 43. Subdivision (47) of subsection (a) of section 14-1 of the general statutes is repealed and the following is substituted in lieu thereof (*Effective July 1*, 2005):

(47) "Modified antique motor vehicle" means a motor vehicle [twenty-five] twenty years old or older which has been modified for safe road use, including, but not limited to, modifications to the drive train, suspension, braking system and safety or comfort apparatus.

<u>Summary of Public Act 05-218:</u> In 2005, it was our understanding this change was a result of feedback from local property tax assessors that the 'blue book' only cover cars up to

20 years old. The 4C's was neither in favor of or opposed to this change.

Public Act 08-150 AN ACT CONCERNING THE DEPARTMENT OF MOTOR VEHICLES.

Sec. 56. Subsection (b) of section 12-71 of the general statutes is repealed and the following is substituted in lieu thereof (*Effective October 1*, 2008):

(b) Except as otherwise provided by the general statutes, property subject to this section shall be valued at the same percentage of its then actual valuation as the assessors have determined with respect to the listing of real estate for the same year, except that any antique, rare or special interest motor vehicle, [for which number plates have been issued under section 14-20] as defined in section 14-1, as amended by this act, shall be assessed at a value of not more than five hundred dollars. The provisions of this section shall not include money or property actually invested in merchandise or manufacturing carried on out of this state or machinery or equipment which would be eligible for exemption under subdivision (72) of section 12-81 of the 2008 supplement to the general statutes once installed and which cannot begin or which has not begun manufacturing, processing or fabricating; or which is being used for research and development, including experimental or laboratory research and development, design or engineering directly related to manufacturing or being used for the significant servicing, overhauling or rebuilding of machinery and equipment for industrial use or the significant overhauling or rebuilding of other products on a factory basis or being used for measuring or testing or metal finishing or in the production of motion pictures, video and sound recordings. Text in brackets [] was deleted by this act. Underlined text was added by this act.

<u>Summary of Public Act 08-150</u> - While the intent of this change was favorable to the hobby (by applying the maximum \$500 assessment to any antique motor vehicle regardless of whether the vehicle had "Early American" special number plates), the bill had the unintended consequence of potentially excluding the application of the maximum \$500 assessment to modified antique motor vehicles with "Early American" plates. This was corrected by Public Act 09-187 discussed below:

Public Act 09-187 AN ACT CONCERNING THE FUNCTIONS OF THE DEPARTMENT OF MOTOR VEHICLES

Sec. 28. Section 14-20 of the general statutes is repealed and the following is substituted in lieu thereof (*Effective October 1*, 2009):

- (a) The [commissioner] Commissioner of Motor Vehicles may issue special number plates for antique, rare or special interest motor vehicles, including antique, rare or special interest motor vehicles that have been modified, such special number plates to be issued on a permanent basis. The commissioner shall charge a fee for such plates which shall cover the entire cost of making the same. An owner of [an] such antique, rare or special interest motor vehicle may use such owner's own porcelain number plate in place of the plates issued by the commissioner provided (1) such plate was originally issued by the department, and (2) such owner files with the commissioner a description and the number of such plate and any additional information the commissioner may require.
- (b) Notwithstanding the provisions of subsection (a) of this section, section 14-18, as amended by this act, and section 14-

21b, the owner of [an] such antique, rare or special interest motor vehicle may be authorized by the commissioner to display a number plate originally issued by the Commissioner of Motor Vehicles corresponding to the year of manufacture of such antique, rare or special interest motor vehicle. The commissioner shall issue a certificate of registration, as provided in section 14-12, as amended by this act. Such registration shall be valid, subject to renewal, as long as the commissioner permits. Thereafter, the registration number and number plates, if any, which were assigned to such motor vehicle before such registration and number plates were issued under this section. shall be in effect. Each such number plate authorized for use by the commissioner shall be displayed in a conspicuous place at the rear of such motor vehicle at all times while the vehicle is in use or operation upon any public highway. A sticker shall be affixed to each such number plate to denote the expiration date of the registration, unless the commissioner authorizes the sticker, or other evidence of the period of the registration, to be placed elsewhere or carried in such motor vehicle. Such sticker may contain the corresponding letters and numbers of the registration and number plate. The commissioner may adopt regulations, in accordance with chapter 54, to implement the provisions of this [subsection] section. Text in brackets [] was deleted by this act. Underlined text was added by this act.

Sec. 29. Subsection (b) of section 12-71 of the general statutes is repealed and the following is substituted in lieu thereof (*Effective October 1, 2009*):

(b) Except as otherwise provided by the general statutes, property subject to this section shall be valued at the same percentage of its then actual valuation as the assessors have determined with respect to the listing of real estate for the same year, except that any antique, rare or special interest motor vehicle, as defined in section 14-1, as amended by this act, shall be assessed at a value of not more than five hundred dollars. The owner of such antique, rare or special interest motor vehicle may be required by the assessors to provide reasonable documentation that such motor vehicle is an antique, rare or special interest motor vehicle, provided any motor vehicle for which special number plates have been issued pursuant to section 14-20, as amended by this act, shall not be required to provide any such documentation. The provisions of this section shall not include money or property actually invested in merchandise or manufacturing carried on out of this state or machinery or equipment which would be eligible for exemption under subdivision (72) of section 12-81 once installed and which cannot begin or which has not begun manufacturing, processing or fabricating; or which is being used for research and development, including experimental or laboratory research and development, design or engineering directly related to manufacturing or being used for the significant servicing, overhauling or rebuilding of machinery and equipment for industrial use or the significant overhauling or rebuilding of other products on a factory basis or being used for measuring or testing or metal finishing or in the production of motion pictures, video and sound recordings. Text in brackets [] was deleted by this act. Underlined text was added by this act.

<u>Summary of Public Act 09-187:</u> This change reflects the current state of the maximum \$500 assessment statutes.


